The purpose of this newsletter is keep current ASHRAE Fellows informed about College of Fellows news and activities, and to inform others about the role, needs and membership of the College of Fellows. The College has been a part of ASHRAE since 1996, during which time it has served multiple functions, including lending expertise to the evolution of the ASHRAE Handbook, providing speakers for local chapters and regions, mentoring young engineers, sponsoring programs at Annual and Winter meetings (most recently in the form of debates on current issues) and serving as ambassadors for ASHRAE. Over the past 5 years, the College has been sponsoring graduate students travel to ASHRAE meetings via a travel award program. To date, at least 7 students have come to ASHRAE meetings under this program.

Having been originated as a legally independent entity, the College of Fellows has recently been transformed into a integral part of ASHRAE. In this new role, the College will continue to serve the Society, and is hoping to inspire young engineers to invest their future with ASHRAE.

The ASHRAE Fellow membership status recognizes ASHRAE members who have attained distinction in the fields of heating, refrigeration, air conditioning, ventilation or the allied arts and sciences through invention, research, teaching, design, original work, or as an engineering executive on projects of unusual or important scope.

The individual must have made substantial contributions and have been a full grade member in good standing for at least ten years prior to the date of their election.

Important Notes:

 \cdot Recognition is in the form of a plaque with a medallion and a lapel pin

· No limit on number awarded per year

• A completed Fellow Nomination Form, a letter of nomination, at least two sponsor letters, a current ASHRAE Bio, and digital photo are required.

· Deadline for nomination: December 1
